# November 15, 2018

At the regularly scheduled meeting of the Chattanooga Fire and Police Pension Fund Board of Trustees held on the 15<sup>th</sup> day of November 2018, President Charlie Thomason presided. The meeting was held at the Pension Office, 6009 John Douglass Drive, Chattanooga, TN 37421.

The meeting convened at 0906 hours with board members Charlie Thomason, Joe Shaw, Kelly Simmons, Nathan Vaughn and Chris Hopkins. Attorney Bill Robinson was also present. Phillip McClain and Mark Coffman were excused absences.

## APPROVAL OF MINUTES

Motion by Joe Shaw and seconded by Nathan Vaughn to approve the minutes of the October 18, 2018 meeting. Motion carried unanimously.

#### APPEARING BEFORE THE BOARD

Janet Neighbors of LBMC, Inc. appeared before the Board to present the findings of the Agreed upon Procedures for the fiscal year ending June 30, 2018. It was noted that there was one member that was not included in the Board minutes for approval, two underpayments to members, one overpayment of a refund, and a slight miscalculation to the COLA formula. Fund Administrator Katrina Abbott explained that these issues have all been corrected and that this shows the benefit of having such procedures performed.

## **LEGAL UPDATE**

Attorney Bill Robinson informed the Board that he had provided the proposed disability legislation and trust agreement to the City Attorney's office for review.
