Rowe Price, and Joseph Zock and Michael Bertash of Tocqueville Asset Management appeared before the Board to make final presentations regarding the RFP for International Equity. Motion by Joe Shaw and seconded by Kelly Simmons to award the RFP to ClearBridge Investments and Tocqueville Asset Management each with half of the current allocation, replacing the current International Equity managers, First Eagle and Harbor International. Motion carried unanimously.
