ADMINISTRATIVE BUSINESS

Motion by Scott Sparks and seconded by Chris Hopkins to approve the Investment Policy Statement annual update. Motion carried unanimously.

The Annual Retirement and DROP Seminar will be June 6, 2024 at 6 p.m. The regular Board Meeting will be held at 2 p.m. and the Quarterly Performance Review will be at 3 p.m.

Katrina Abbott updated the Board on the status of the legislation passed in 2021 allowing members to purchase prior service credit with municipalities towards TCRS service. This act was updated in 2022 with further instructions that no longer require municipalities to transfer employer contributions to TCRS, but still allows members to purchase prior service credit with their own funds.

INVESTMENT REPORT

Stee Roth of Dahab Associates presented the 4Q-2023 performance summary. As of December 31, 2023, the Fund has returned 8.4% for the quarter and ranked in the 36th percentile of the Public Fund Universe. Over the trailing twelve-month period, the Fund returned 12.9% and ranked in the 52nd percentile of the Public Fund Universe. The performance summary does not include updated results from all managers.
