# MEETING OF THE BOARD OF TRUSTEES

## September 06, 2018

At the regularly scheduled meeting of the Chattanooga Fire and Police Pension Fund Board of Trustees held on the 6<sup>th</sup> day of September 2018, President Charlie Thomason presided. The meeting was held at the Pension Office, 6009 John Douglass Drive, Chattanooga, TN 37421.

The meeting convened at 0906 hours with board members Charlie Thomason, Joe Shaw, Kelly Simmons, Nathan Vaughn, Phillip McClain, Mark Coffman and Chris Hopkins. Attorney Bill Robinson was also present.

# **APPROVAL OF MINUTES**

Motion by Phillip McClain and seconded by Kelly Simmons to approve the minutes of the August 16, 2018 meeting. Motion carried unanimously. #### **ADMINISTRATIVE BUSINESS**

The Board reviewed the bills paid since the last meeting.

Fund Administrator Katrina Abbott advised the Board that the Staff has reviewed the results of the election and have found no discrepancies.

Administrator Abbott provided the renewal quote for USAble Life Insurance to the Board. The Fund outsourced the \$10,000 death benefit to a life insurance company in October 2011 in an effort to reduce expenses; to protect the Fund from a major catastrophic event; and to provide a tax-free benefit to beneficiaries. As a result, the Fund has realized a savings of nearly \$236,000 over a period of seven years. The premiums have increased as the plan has gained experience and reached more of a break-even point rather than a savings. Katrina Abbott recommended that the Board renew the coverage for the two year period and re-evaluate at the end of the two years to if the insurance continues to be worth the expense. Motion by Joe Shaw and seconded by Kelly Simmons to renew the USAble Life Insurance for the two-year period. Motion carried unanimously.

Fund Administrator Katrina Abbott discussed the Request for Proposals from US Bank and Comerica regarding Custodial Services, noting that both finalists appeared to be excellent choices and comparable in fees. Katrina Abbott recommended US Bank as the replacement for Custodial Bank. Motion by Joe Shaw and seconded by Mark Coffman to appoint US Bank as Custodian and terminate the current custodial relationship with Wells Fargo as soon as feasible. Motion carried unanimously.

Fund Administrator Katrina Abbott updated the Board on the pending disability applications. The Board scheduled the hearing for Firefighter Adam Cannon on September 25, 2018 at 10:00 a.m.
