# MEETING OF THE BOARD OF TRUSTEES

# CHATTANOOGA FIRE & POLICE PENSION FUND

# February 20, 2020

At the regularly scheduled meeting of the Chattanooga Fire and Police Pension Fund Board of Trustees held on the 20<sup>th</sup> day of February 2019, President Joe Shaw presided. The meeting was held at the Pension Office, 6009 John Douglass Drive, Chattanooga, TN 37421.

The meeting convened at 0904 hours with board members Joe Shaw, Britt Bradshaw, Nathan Vaughn, Kelly Simmons, Phillip McClain and Chris Hopkins. Attorney Bill Robinson was also present. Charlie Thomason was an excused absence.

#### APPROVAL OF MINUTES

Motion by Kelly Simmons and seconded by Nathan Vaughn to approve the minutes of the February 06, 2020 meeting. Motion carried unanimously.

#### APPEARING BEFORE THE BOARD

Fire Captain Jerry Copeny appeared before the Board to submit his application for a job-related disability. Captain Copeny is currently on light duty and has provided all necessary documentation. The Board accepted his application and noted this could be a lengthy process.

Attorney Bill Robinson updated the Board on the status of the request for a private letter ruling from the IRS regarding the tax exemption of survivor's benefits in regard to job-related deaths and disabilities. Katrina Abbott informed the Board the Fund has received a large volume of documents from Wells Fargo, which are under review and will be a lengthy process.

# **ADMINISTRATIVE BUSINESS**

The Board reviewed the bills paid since the last meeting.

Attorney Bill Robinson explained to the Board that he also sits on the Board for Sculpture Fields of Montague Park, a Non-Profit Organization. Sculpture Fields of Montague Park has just attained its own building and is trying to locate furnishings. Bill Robinson asked if the Board would consider donating its previous conference table that has been in storage for several years. Motion by Kelly Simmons and seconded by Chris Hopkins to donate the requested item. Motion carried unanimously.

Katrina Abbott discussed an issue that arose with disability applicants facing possible termination of employment and the potential loss of health insurance prior to a disability determination being finalized. Katrina Abbott was able to speak with officials with the City of Chattanooga and explain the Fund's disability process, which is typically not completed in a short time frame and any termination of employment and loss of health insurance coverage could be a detriment to the member. Members will now be placed on leave without pay until a decision has been made regarding disability by the Fund.

Policy committee will meet after adjournment of the regular Board meeting today.

#### **INVESTMENT REPORT**

Steve Roth of Dahab Associates presented the 4Q-2020 performance summary. As of December 31, 2019, the Fund has returned 6.2% for the quarter and 20.1% for the trailing twelve-month period. The performance summary does not include updated results from private equity managers. Dahab recommended reallocating \$3 million from Vanguard Mid-Cap and \$1 million from AQR Emerging Markets to Johnson Institutional Core Fixed Income. Motion by Kelly Simmons and seconded by Phillip McClain to approve Dahab's recommendation. Motion carried unanimously.
