MEETING OF THE BOARD OF TRUSTEES

CHATTANOOGA FIRE & POLICE PENSION FUND

August 06, 2020

At the regularly scheduled meeting of the Chattanooga Fire and Police Pension Fund Board of Trustees held on the 6th day of August 2020, President Joe Shaw presided. The meeting was held via teleconference and the number was posted to the Fund's Facebook page for the public to join.

The meeting convened at 0908 hours with board members Joe Shaw, Britt Bradshaw, Nathan Vaughn, Phillip McClain, Cal Long and Chris Hopkins. Attorney Bill Robinson was also present. Kelly Simmons was an excused absence.

APPROVAL OF MINUTES

Motion by Nathan Vaughn and seconded by Britt Bradshaw to approve the minutes of the July 16, 2020 meeting. Motion carried unanimously.

APPEARING BEFORE THE BOARD

Firefighter Senior Matthew Long appeared before the Board to submit his application for a job-related disability. FFS Long is not actively working in his normal capacity and has provided all necessary documentation. The Board accepted his application and noted this could be a lengthy process.

LEGAL UPDATE

Board Attorney Bill Robinson updated the Board on the status of the private letter ruling the Fund has requested from the IRS regarding the taxation of benefits for beneficiaries of members that have retired on a job-related disability or survivors of job-related deaths. The IRS has requested additional information that has been or will be provided.

Fund Administrator Katrina Abbott updated the Board on the status of the pending suit for accounting against its former trustee, Wells Fargo Bank, N.A. A Special Master has been agreed upon and appointed to oversee the remaining discovery and outstanding motion to compel.

ADMINISTRATIVE BUSINESS

The Board reviewed the bills paid since the last meeting.

Fund Administrator Katrina Abbott presented the Board with a revised Disability Policy, Member's Guide to Disability, and Summary Plan Description that included updated language regarding the Board's determination of disability applications. After additional Board discussion, motion by Britt Bradshaw and seconded by Cal Long to approve the revisions with suggested minor grammatical corrections. Motion carried unanimously.

INVESTMENT REPORT

Steve Roth and Barry Bryant of Dahab Associates presented the 2Q-2020 performance summary. As of June 30, 2020, the Fund has returned 13.6% for the quarter and ranked in the 29th percentile of the Public Fund Universe. Over the trailing twelve-month period, the Fund returned 4.2% and ranked in the 32nd percentile of the Public Fund Universe. The performance summary does not include updated results from private equity managers. Dahab recommended reallocating \$1.5 million from Vanguard Mid-Cap and \$1.5 million from Vanguard Large Cap to Johnson Institutional Core Fixed Income. Motion by Chris Hopkins and seconded by Nathan Vaughn to approve Dahab's recommendation. Motion carried unanimously.
