INVESTMENT REPORT

Barry Bryant of Dahab Associates presented the 4Q-2020 performance summary. As of December 31, 2020, the Fund has returned 11.0% for the quarter and ranked in the 27th percentile of the Public Fund Universe. Over the trailing twelve-month period, the Fund returned 15.4% and ranked in the 17th percentile of the Public Fund Universe. The performance summary does not include updated results from all managers. Dahab recommended reallocating \$5 million from Vanguard Mid-Cap and \$2 million from PIMCO Small Stocks Plus to TCW Met West TR Plan. Motion by Britt Bradshaw and seconded by Nathan Vaughn to approve Dahab's recommendation. Motion carried unanimously.
