At the regularly scheduled meeting of the Chattanooga Fire and Police Pension Fund Board of Trustees held on the 20th day of May 2021, President Joe Shaw presided. The meeting was held at the Pension Office, 6009 John Douglass Drive, Chattanooga, TN 37421.

INVESTMENT REPORT

Barry Bryant and Steve Roth of Dahab Associates presented the 1Q-2021 performance summary. As of March 31, 2021, the Fund has returned 3.6% for the quarter and ranked in the 30th percentile of the Public Fund Universe. Over the trailing twelve-month period, the Fund returned 39.5% and ranked in the 16th percentile of the Public Fund Universe. The performance summary does not include updated results from all managers. Dahab recommended reallocating \$2 million from Vanguard Large-Cap to TCW Met West. Motion by Chris Hopkins and seconded by Phillip McClain to approve Dahab's recommendation. Motion carried unanimously.
