APPROVAL OF MINUTES

President Joe Shaw informed the Board that Fund Administrator Katrina Abbott must have a signed authorization form permitting her to obtain a corporate credit card on behalf of the Fund. Currently, individual staff members have credit cards that can be used for Fund business. Those individuals are personally responsible for that debt and, if an individual leaves employment of the Fund, the Fund Administrator must retrieve the card. The new card will be a corporate card for the Fund, with approved signers. This is a more efficient and proper way to maintain a credit card for Fund related expenses and the authorized signers will no longer be personally responsible for authorized charges on the card. Motion by Scott Sparks and seconded by Nathan Vaughn to sign the necessary authorization permitting Fund staff use of corporate credit for conducting Fund business.
